- 3. No grooming in the building is allowed (other than light brushing no stripping, blow dryers, etc.)
- 4. No chalking or powdered dogs.
- 5. ALL Non-member Crating of Conformation dogs must be in the "Building 17 or

- "Annex" portion of the facility.
- 6. All dogs entering the facility are required to have shots as recommended by their veterinary based on the age of the dog. Since Judges will be handling the dog's mouths, please be prepared to show evidence (tags or certificate) of Rabies inoculation.
- 7. All dogs must be at least 4 months old.
- 8. Absolutely NO bitches in season are allowed to be shown or on the MDTC premises, inside or outside the buildings. Any violation of this will result in the offender being asked to leave the premises immediately. Contact Cat
